IV. Mom of the Month

The Mom of the Month (MOM) format is our group's new way to handle events. Members will be divided into 12 group, one team for each month of the year. Each MOM team will meet, plan and hostess events for their assigned month. It is the prayer of leadership that this will facilitate close-knit relationships between members and give the feeling of group ownership to all members.

V. Code of Conduct

In order to maintain a safe haven for our children and yours, we have instituted a Code of Conduct for all members. Each event or activity sponsored by or associated with RRHome provides opportunities for training our children in appropriate behavior with various ages, understanding that we desire to support each other in the Godly raising of our children.

- 🗣️ Each parent is responsible to properly attend their own children at all times or to previously arrange for another adult to be responsible for them.
- 🗣️ No child is permitted to continually or excessively disturb other children present with bullying, teasing, course jesting, rough play or crude talk.
- 🗣️ Violent behavior in the form of threats, physical contact or striking is not allowed including willful defacing of property.

Learning good public behavior means talking to our children before we arrive about what is expected and correcting them when improper attitudes are present.

Other parents in attendance are not expected to look after someone else's children but will be allowed to intervene if there is a need. The responsible adult should be notified if this occurs.

If your child exhibits any of the above behavior at a RRHome sponsored event your family should choose to leave the event for the safety of all our children. If you choose not to leave you may be asked to leave by another parent.

If we witness offending behavior, the Leadership Board will begin an intervention procedure which will focus on restoration through view points, appropriate boundaries and acceptable behavior.

All warnings will be in writing. The 3rd and final warning will result in the removal of the family from the RRHome group for one year. If you are removed from the group twice, the second removal is permanent.

VI. Statement of Faith

1. The Bible, in its original manuscripts, as a whole or in part, is without error and is the infallible revelation of God to man. "And the Word became flesh, and dwelt among us, and we saw His glory, glory as of the only begotten from the Father, full of grace and truth."* (John 1:1-3, 14) *"... a virgin will be with child and bear a son, and she will call His name Immanuel."* (Isa 7:14, Mat 1:23) *"For we do not have a high priest who cannot sympathize with our weaknesses, but One who has been tempted in all things as we are, yet without sin."* (Heb 4:15)

3. We are all sinners by nature and by practice and therefore imperfect in our flesh. Jesus paid the price for our sins by death upon a cross, and then rising again on the third day, that all who receive Him may be forgiven. *"... for all have sinned and fall short of the Glory of God."* (Romans 3:23)

4. Salvation is a free gift offered to all who will accept, and is not something to be earned by works. Salvation has already been purchased for us by the sacrificial death of Jesus. *"For the wages of sin is death, but the free gift of God is eternal life in Christ Jesus our Lord."* (Romans 6:23) *"For God so loved the world, that He gave his only begotten Son, that whoever believes in Him shall not perish, but have eternal life."* (John 3:16)

5. We have the right to raise and teach our children in a Godly manner and that they are gifts given to us from God, placed under our stewardship. We believe we have the right to teach them at home. *"These words, which I am commanding you today, shall be on your heart.
